1. Decision summary

The Delegated Officer has determined to transfer works approval W6435/2020/2 to Greatland Pty Ltd. The transfer is administrative in nature therefore it does not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the transfer made pursuant to section 64 of the *Environmental Protection Act 1986* (EP Act). The existing Decision Reports for the works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Transfer Application summary

Works approval W6435/2020/2 was held by Newcrest Operations Limited. On 30 December 2024, the department received an application to transfer the works approval to a new holder, Greatland Pty Ltd, under section 64 of the EP Act.

Works approval W6435/2020/2 relates to the Havieron Project Category 85 Sewage facility on Mining Tenement M45/1287 in East Pilbara.

The premises relates to the categories and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* which are defined in the existing works approval W6435/2020/2.

The transfer is limited to updating the occupier's name, registered business number, registered business address, and file number.

3. Consultation

On 25 February 2025 the works approval holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
