1. Decision summary

The Delegated Officer has determined to make amendments to works approval W6452/2020/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This amendment report documents the amendments made pursuant to section 59(1)(k) and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

3. Amendment summary

Works approval W6452/2020/1 is held by Ausvision Rural Pty Ltd for the Beaufort River Meats (the Premises), located at 46 Marci Road Beaufort River WA 6394. The Premises relates to the categories and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in the existing works approval W6452.

On 30 April 2025, the works approval Holder submitted an application to the department to amend works approval W6452 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to extending the duration of the works approval to December 2027 to allow the completion of construction works for a dewatering area and the operations and reporting for the desludging of two wastewater treatment ponds.

4. Conclusion

Based on the assessment in this amendment report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
