1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6585/2021/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Amendment summary

Works Approval W6585/2021/1 is held by Black Cat (Bulong) Pty Ltd (Works Approval Holder) for the Imperial Majestic Mine (the Premises), located at Mining tenement M25/350.

The Premises relates to the categories and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6585/2021/1.

On 22 August 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6585/2021/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to updating the:

- works approval holder name from Black Cat (Bulong) Pty Ltd to Black Cat (Kal East) Pty Ltd;
- premises name from Imperial Majestic Mine to Kalgoorlie East Gold Project (KEGP);
- occupier's registered business address from Level 3, 52 Kings Park Road, West Perth WA 6005 to Level 4, 507 Murray Street, Perth WA 6000; and
- extending works approval expiry date as it is due to expire on 12 December 2025.

The Works Approval Holder has requested a two-year extension to the duration to allow the completion of commissioning activities and Time Limited Operations as required by works approval W6585/2021/1.

3. Consultation

On 11 November 2025 the Works Approval Holder waived the comment period and confirmed the premises name and registered address were correct.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
