1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6707/2022/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Works Approval W6707/2022/1 is held by Anax Metals Limited (Works Approval Holder) for the Whim Creek Copper Project (the Premises), located at Mining Leases M47/236, M47/237, M47/238, M47/443, North Coastal Highway, WHIM CREEK WA 6718.

The Premises relates to the categories and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6707/2022/1.

On 10 June 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6707/2022/1 under section 59B of the *Environmental Protection Act* 1986 (EP Act). The amendment is limited only to extending works approval expiry date.

The Works Approval Holder is seeking the extension due to a lack of commencement of activities onsite. To date no activities have occurred onsite under W6707/2022/1 due to a lack of project funding. The Works Approval Holder recently announced a strategic funding partner (May 2025) to assist with the project start up and it is anticipated that activities under W6707/2022/1 will commence within the next 12 to 18 months.

The Premises map Figure 1 and Premises boundary coordinates have also been updated as part of this amendment.

3. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 26 June 2025. On 04 July 2025 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
