## 1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6719/2022/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing Works Approval will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

### 2.1 Regulatory framework

In amending the Works Approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

### 2.2 Application summary

Works Approval W6719/2022/1 is held by Black Cat (Lakewood) Pty Ltd (Works Approval Holder) for the Lakewood Gold Processing Facility (the Premises), located at Lakewood Gold Processing Facility, Mount Monger Road, Lakewood WA 6431.

The Premises relates to the category 5 and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6719/2022/1.

On 23 April 2025, the Works Approval Holder applied to the department to amend Work Approval W6719/2022/1 under section 59 and 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited to changing the Works Approval Holder's name.

## 3. Consultation

On 23 June 2025, the Works Approval Holder was provided with the draft Amendment Report and Revised Licence and invited to submit comments on the proposed amendments. On 24 June 2025, the Works Approval Holder waived the remainder of the consultation period so that the amendment could be progressed.

## 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that a Revised Works Approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
