1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6769/2023/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged. This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Works Approval W6769/2023/1 is held by Onslow Iron Pty Ltd (Works Approval Holder) for the West Pilbara Iron Ore Project (the Premises), located at mining tenements M08/480, M08/484, G08/88, L08/67, L08/68, L08/69 and L08/181.

The Premises relates to the categories 5, 12, 52, 54, 57, 64, 73 and 77 and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations* 1987 (EP Regulations) which are defined in existing Works Approval W6769/2023/1.

On 7 May 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6769/2023/1 under section 59B of the *Environmental Protection Act* 1986 (EP Act). The amendment is limited only to extending the authorised duration of commissioning for the Power Station, for a period not exceeding 210 calendar days.

3. Consultation

On 24 June 2025 the Works Approval Holder received a copy of the amended Works Approval and Amendment Report. On 30 June 2025 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
