Details of non-compliance: Paper records for calibration of the Dust Concentration Monitors (DCM) used for continuous monitoring of particulate emissions from Calciner numbers 1, 2, 3, 4, 6 & 7 could not be located. Administrative record keeping requirements are set out in Appendix A of the Continuous Emission Monitoring System (CEMS) code. What was the actual (or suspected) environmental impact of the non-compliance? NOTE - please attach maps or diagrams to provide insight into the precise location of where the noncompliance took place. No known or suspected environmental impact resulted from the non-compliance as maintenance and calibration of the DCMs is managed in accordance with manufacturer's directions and through Alcoa's system based maintenance management scheduling program. Cause (or suspected cause) of non-compliance: Lack of a defined administrative process to manage hard copy DCM calibration records. No electronic platform available to hold data records. Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance: Alcoa's investigation process determined the cause of this event and has/ is undertaking actions to prevent recurrence. This includes thorough site auditing of the calibration and correlation process (and implementation of resultant action plan), updating procedural control to include electronic system-based record keeping and inclusion in the calibration internal training package. A filter press failure within the residue filtration facility resulted in approximately 2kL of slurry material being released from the press under pressure, of which all but approximately 10L was captured in designated sealed bunding. The 10L was released to unsealed ground immediately adjacent to the filtration facility within the refinery premises.

No known or suspected environmental impact resulting from the non-compliance due to the immediate recovery of slurry released to unsealed ground.					
Cause (or suspected cause) of non-compliance:					
Improper seal of the filter plates likely due to a small restriction or blockage between the filter plates that resolved itself during the next filter cycle.					
Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:					
Immediate recovery of the released material and collection/disposal of impacted ground material. Options for improving bunding, containment and sealing within and surrounding the filtration facility is undergoing review.

Minor failures in primary containment allowed sulphuric acid to enter the bund of the temporary acid facility where it escaped through an undetected tear in the acid resistant liner. Due to the nature of the failure, neither the failure nor the released material could be rectified or cleaned up immediately.

Minor environmental impact with small quantities of acid expected to have penetrated through hardstand to ground. The area of potential contamination is to be investigated and remediated during facility decommissioning expected to occur in 2023.			
Cause (or suspected cause) of non-compliance:			
Flange failure caused by an incorrect gasket, and tear in the HDPE acid resistant bund liner likely caused during maintenance activities conducted within the bund.			
Action taken to mit non-compliance:	tigate any adverse effects	of non-compliance	and prevent recurrence of the
The facility was dismantled enabling some contaminated material to be removed. The facility was reviewed and learnings from root causes identified were incorporated into the reconstructed facility. This included improved sump design and increased mechanical protection for the acid resistant liner.
