We exceeded our allowable discharge to land of Total Nitrogen, our Licence limit is 300kg per hectare per year, and actual discharge for 2018 was 385.9 per hectare.

No visible or obvious immediate impact, the upcoming possible contaminated site investigation due to be completed in July should provide more information about any possible longer term impacts on the soil or immediate environment.						
Cause (or suspecte	ed cause) of non-compliance					
Unusually high nutrient levels in our waste water system due to higher than normal inputs late in 2017, in particular one incident when the majority of blood from 1 full day's production was incorrectly diverted into our waste system. Total nitrogen levels in our storage pond have been abnormally high since that event peaking at 330 mg L in June 2018, however the most recent readings show a dramatic decrease with August 2018 reading of 210mgL and December 2018 190mgl, this level is in line with historical levels.						
Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:						
Changes have been made to production practices and procedure checking we will also be making changes to the production floor drainage system to reduce the amount of blood that enters our waste water system during normal production, the change will be by way of extending the bleed pit to capture more blood during production.
