
Details of non-compliance:

Treated wastewater was discharged onto unsealed ground adjacent to lined evaporation ponds. This overspill resulted in a breach of the requirement to maintain a vertical freeboard of 300 mm.

What was the actual (or suspected) environmental impact of the non-compliance?

No known or suspected environmental impact. Discharged water pooled adjacent to the pond and was sampled on the 12/07/2021. Due to low level TRH readings no soil remediation was required and there has been no known or suspected environmental impact.



Cause (or suspected cause) of non-compliance:

Transfer pump from the retention ponds failed on low flow alarm, and the high-level alarm was not monitored in the remote monitoring centre. In field inspection/monitoring did not identify the rising pond level.

Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:

Windrows were built to contain the overflow and the associated wash-bays were tagged out of service.

Mine services water carts were prioritised to service OB24 Turkeys Nest to assist with draw down of the evaporation ponds.

Remote monitoring of alarms and daily in-field inspections have been implemented to limit the potential for overflow events.
