

Site Boundaries & Drainage

There are two main areas of composting - Areas 1 and 2 on the aerial map. Compost Area 1 runs off to collection point 1A and compost Area 2 runs off to collection point 2A. Both of these collection points are piped to the leachate dam.

The third area of composting is Hardstand extension Area 3. It has its own collection point 3A which connects into existing drainage to the leachate dam.
