Atlas Group Pty Ltd - Compost Site Annual Monitoring Report.

In accordance with condition G2 and G4 of licence number L7329/1997/8, this report is submitted for the Atlas Compost Manufacturing and Soil Blending Facility - Category 67A.

During the 2021 reporting period the Atlas Compost Manufacturing and Soil Blending Facility did not receive any organic material for processing.

Upon assessment of the Annual License Fee during October 2017 the nominated throughput of the facility was adjusted to less than 500 tonnes per annum.

G2 (a) Monitoring

(i) Measures taken to Control Pests and Vermin

- No raw organic material was received, stored or processed on site during the 2021 reporting period thus eliminating the potential for pest and vermin problems.
- There have been no sightings of pests or vermin during the reporting period.

(ii) Fire Prevention

There have not been any incidents involving fires at the composting facility.

Firebreaks on the site have been seasonally maintained.

A site-based water truck with firefighting and rapid-fill capacity is at hand and available as a mobile water supply.

October 2021 Annual firebreak maintenance was performed.

(iii) Dust Suppression.

There have not been any operations at the composting site, therefore eliminating any potential dust related problems.

The site-based water truck is available for dust suppression as and when required.

(iv) Wind-Blown Waste

There have not been any incidences of windblown waste. No material has been received on site for processing during the 2021 reporting period.

(v) Stormwater Runoff Control

Runoff is diverted by the stormwater containment bund (illustrated in attachments 1 & 2 of the licence documentation L7329/1997/8-File number 2010/002636 amendment date 22 October 2015), collected in a containment basin (or retention basin) and used for dust suppression purposes as and when required.
