Inert landfilling at Moonyoonooka Sand Quarry which is located at Lot 4 Abattoir Road, Moonyoonooka is undertaken within the void created from previous sand extraction. Whilst the sand pit has been in operation for more than 50 years; in the last 21 years sand extraction has been restricted to only our company vehicles accessing and utilising the site with significantly less volumes of material being extracted. Moonyoonooka Sand Quarry is fenced, the gates are padlocked and it has appropriate signage along the boundaries.

The block is approximately 200 acres and is 13 kilometres east of Geraldton and the nearest residence is more than 450- 500 metres north east of premises boundary. The surrounding land is mainly used for agriculture. Geraldton Meat Exports is located adjacent to site.

Moonyoonooka Sand Quarry only accepts and buries clean fill and inert waste -types 1 and 2. Annual figures for clean fill/inert waste are normally 100 to 2000 tonne and the number of tyres accepted is normally 50 to 200. In addition, we make sure that the number of tyres on site which are above ground before burying are less than 30. No asbestos materials are accepted or buried at the site.

There have been no incidents, complaints or issues with the site. There have been no fires, air, odour, noise or light emissions at this site. There have been no discharges to water or land; and there is no chemical storage at this site. There have been no dust issues on this site but if this problem arose, we would suppress with our water cart as required.
