

Cause (or suspected cause) of non-compliance:			
3.2.1 – Initial stack testing during plant commissioning was deemed unacceptable by DER. Re-testing was performed and submitted at the end of 2016. KEC have been awaiting feedback to confirm stack test results are compliant prior to ordering another (rather costly) stack test.			
Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:			
There is no direct adverse effect from the stack test not being performed. It is performed for monitoring purposes. There have been no malfunctions with the baghouse operation to suggest there would be any breach of monitored emission standards. 3.2.1 – Once clarification given over stack test compliance regular yearly stack tests will be performed. There will be no further ambiguity.
