Date(s) of non-Condition no: 1.2.1 March 2020 compliance: Details of non-compliance: The annual quantity of category 64: Class II or III putrescible landfill exceeded the 1,000 tonnes per annum limit during the last month of the reporting period (March). What was the actual (or suspected) environmental impact of the non-compliance? NOTE - please attach maps or diagrams to provide insight into the precise location of where the noncompliance took place. No actual environmental impact has occurred as a result of this exceedance. Cause (or suspected cause) of non-compliance: With increasing waste amounts going to landfill, the Nova Operations instigated organic waste composting measures that were adopted in December 2019. This reduced the monthly average to below capacity requirements, however it was not enough to prevent a minor exceedance in this reporting period. Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance: IGO Nova operations will have the food waste composting measures in place for the entirety of next year's reporting period. This is forecast to reduce the landfill amounts by approximately 29% and return the Nova Operations to within its license requirements. Was this non-compliance previously reported to DWER? Yes, and
