**Application for exemption under regulation 5(3)**  
of the *Waste Avoidance and Resource Recovery Levy Regulations 2008*

**FORM LL02-10**

Regulation 5 of the *Waste Avoidance and Resource Recovery Levy Regulations 2008* (Levy Regulations) sets out the circumstances under which licensees can apply to claim an exemption from the regulations.

A licensee of a category 63 licensed landfill may by application in an approved form claim an exemption from the requirements of regulation 10(5) and (6) in respect of a return period if no waste has been disposed of landfill on the licensed landfill.

**This exemption provision is intended for only Category 63 inert landfill facilities.**

Applicants should note that exemptions should be in place prior to 28 days after the end of the return period to avoid landfill levy liability arising.

Before submitting this application form please ensure you have done the following:

- Completed and signed the form as required.
- Included copies of the supporting information required as set out in the form.
- Read the Landfill Levy Fact Sheet No. 2 – Exemptions from the Levy Regulations ([www.der.wa.gov.au/landfilllevy](http://www.der.wa.gov.au/landfilllevy)).
