### Works approval conditions

The works approval holder must ensure that the following conditions are complied with:

#### **General conditions**

- 1. The works approval holder, except where storage is prescribed in section 1.3, shall only store substances that are classed as dangerous goods below placard quantities or environmentally hazardous materials not classified as dangerous goods if they are stored in accordance with the Code of Practice for the Storage and handling of dangerous goods.
- 2. The works approval holder shall undertake commissioning in accordance with the commissioning plan contained in KCGM Fimiston Emissions Reduction Project Works Approval Supporting Information and revised commissioning plan.
- 3. The works approval holder shall commission the gold room retort and kiln off-gas cleaning project for a period not exceeding 59 days or in accordance with the revised commissioning plan.

#### **Environmental commissioning requirements**

- **4.** The works approval holder must submit a commissioning report to the CEO for approval within two months of completion of commissioning. The report must include:
  - (a) results of any monitoring conducted;
  - a summary of the environmental performance of the equipment as installed against the design specification set out in the works approval application, or target(s) set out in this works approval;
  - (c) a review of performance against the works approval conditions; and
  - (d) where they have not been met, measures proposed to meet design specification and/or works approval conditions, together with timescale for implementing the proposed measure.




Figure 1: Map of the boundary of the prescribed premises

The boundary of the prescribed premises is shown in the map below (Figure 1).
